

# **FACILITY RULES**

- Children ages 12 and older may utilize the Freestone Recreation Center unattended. Children under the age of 12 not participating in a registration based program, event or class must be accompanied and supervised by an adult age 18 years or older at all times.
- 2. All persons in the facility are expected to conduct themselves in a manner that is courteous and respectful of other guests, staff, the facility and equipment. Compromising your safety or the safety of others, verbal or physical threats, aggressive behavior or fighting will result in immediate suspension of all parties.
- 3. This facility is a family-friendly environment. Clothing with offensive content is prohibited. Appropriate attire is required at all times to include shirts covering the entire torso, pants/shorts and shoes.
- 4. Photographs without an individual's permission are prohibited. This includes use of all technology with built-in camera devices (i.e. cell phones, PDA's, cameras, etc.).
- Music and other personal media equipment should be utilized with headphones or earbuds. The use of external speaker systems is prohibited.
- 6. Bikes, skateboards, rollerblades/skates, scooters and other recreational motorized/ wheeled devices are prohibited inside the building and should be secured in designated racks outside the facility.
- 7. Only service animals as defined by state statute are permitted in the facility. Unless part of a Town sponsored or approved activity, no other animals are allowed.
- 8. Smoking of any kind is prohibited at facility entrances and inside the building. Designated smoking areas are provided 25 feet from the main entrance.
- Alcoholic beverages and illegal drugs may not be consumed prior to or while using the facility. Staff reserves the right to refuse service to anyone suspected of being under the influence.
- 10. Food, chewing gum and drinks are permitted in lobby areas only. Glass containers are prohibited at all times. With the exception of the climbing area, water is allowed throughout the facility if in a sealed, shatterproof container.
- 11. Team coaching, personal training, direct/indirect supervision of organized practices and/or drills are prohibited without a facility permit and certificate of insurance.
- 12. The center assumes no responsibility for personal items. All patrons are encouraged to secure their own possessions in their personal vehicle or in a facility locker.
- 13. Only registered participants, permit holders, day pass users and facility staff are allowed in classrooms and/or the gymnasium.
- 14. Facility guests are required to purchase a wristband and sign a waiver of liability prior to participating in center activities. Wristbands are your proof of purchase and must be worn at all times.
